## Progress review of maintenance and development - Success stories, challenges, lessons learned

- HIMSS IIP continues to maintain the capabilities and guidance, the test specifications and test plan based on annual feedback from the Technical Advisory Panel (TAP)
- Recognized vendors continue to provide positive feedback about the value of the program, while HIMSS and Drummond Group work to expand awareness of the program in the next phase.
- Received request for gap analysis between HIMSS IIP program and ONC F1 Cert criteria.
- Increase in the stability of the test tool
- Working toward increased stability of the test plan

## Progress review of maintenance and development - Patches, upgrades or planned enhancements

- Updates made to the test plan (see next slide)
- Technical Advisory Panel (TAP) will meet January 30
  - Will provide ONC with an update at our next review
- Gap Analysis by Drummond in process

#### Progress review of maintenance and development - Documentation of change history for tool and/or plan

- Test Plan 7.0 Updates:
  - Adjustments of patients' birth dates to stay within immunization schedule windows
  - Minor test plan editorial items corrected

#### **Unresolved** issues

- NIST tool is down as part of the partial government shutdown
- Drummond Group is hosting versions of all NIST tools during government shutdown, however test plan 7.0 is not currently available.
- IIP testing can proceed with test plan 6.0, while Drummond Continues to work to resolve tool issue

# Policy and technical alignment - Review of test procedures and CCGs

- Drummond Group developed a Gap Analysis to guide vendors in identifying additional functionality required to test with IIP
- Test Plan steps/procedures have not changed at this time
- Test Plan and Capabilities document will be updated after TAP meeting
