- Med List effort is a consumer of FHIR Standards
 - » Phase 1 standards specifications were based on FHIR DSTU version 2
 - » FHIR servers in sandbox and App developers support FHIR DSTU version 2
- FHIR STU Version 3 released on **March 22, 2017**
