Simplified Goal

By June 30th, Med List participants should demonstrate expanded connectivity, enhanced usability features and the ability to share medication lists with providers.

Maintain flexibility to execute:

- Additional providers deploying FHIR-enabled systems
- Improved patient-facing workflow and app features
- Provider-facing workflow for viewing shared medication lists

Tactical Approach: Work Stream Organization

Usability Work Stream:

Address making medication lists usable and useful. Develop features and supporting workflows to improve accessibility of the medication list in a way that is useful to the patient.

Monthly Calls to review:

- Progress to share med lists with others such as providers
- Progress on addressing usability features such as patient annotation

Technical Work Stream:

Adopt and implement the standards, APIs and workflows necessary to enable patient access to medication lists through third party applications within test or live provider environments.

Monthly Calls to review:

- Provider deployment and testing
- Relevant HL7 FHIR/ medication resource guidance



For Discussion: Proposed 2017 Goals

<u>Goal 1(For Vendors)</u>: Consistent and expanded implementation of FHIR medication resources necessary for med list functionality.

- 6/2017 Obtain HL7 guidance to support consistent implementation and use of FHIR medication resources (MedicationStatement, MedicationOrder*) by vendors.
- 12/2017 vendors have outlined a clear plan to implement MedicationDispense FHIR resource in support of medication history data and have identified partner organizations for testing exchange of dispense and claims data.

Goal 2 (For App Developers): Address usability issues by improving app user experience.

- 6/2017 Improve user experience by addressing recommendations made by Usability and Workflow work stream.
- 6/2017 Demonstrate ability to perform sharing of medication list in a test environment.
- 12/2017 Apps demonstrate ability to share medication information based on patient choice, for example, with another app or provider portal.

Goal 3 (For Providers): Adopt vendor FHIR solutions and roll out med list functionality to patients.

- 6/2017 Provider organizations have deployed FHIR servers and apps in their test environments; and are engaged in testing and refining med list aggregation and workflow
- 12/2017 Provider organizations have deployed med list functionality in production and made available to real patients.

<u>Goal 4 (For ONC/HHS)</u>: Promote med list effort as a model for public-private collaboration and ensure effort participants are implementing standards to support broad federal interoperability initiatives.
